..... in consideration of my participation in NAKAWAN ULTRA (herein referred to as "THE EVENT") organized by PUTRA TRAIL RUNNING CLUB and MEP VENTURES SDN BHD ("THE ORGANIZER") to be held from 9th to 10th December 2022, agree to this release of claims, waiver of liability and assumption of risk.

1. I have read, understood, and agreed to the relevant race information, rules and regulations and other information provided on THE EVENT website and any event information notes relating to THE EVENT.
2. I declare, as a condition for entry to THE EVENT, that I am physically fit for THE EVENT and that I am not aware of any illness, injury or other physical disability which may cause me injury or death while participating in THE EVENT. If I become aware of any medical condition or impairment that may put me at risk during THE EVENT, I will withdraw from the race.
3. I understand that it is a condition for participation in THE EVENT to be fully vaccinated against Covid-19 on race day. I agree that it is my responsibility to take all appropriate steps to minimize the risks related to Covid-19 and that the Organizers cannot be held responsible for any Covid-19 infections associated with the event.
4. I understand the physical nature and remoteness of THE EVENT. I understand that participating in THE EVENT is potentially hazardous, and that I should not enter and participate unless I am medically able and properly trained. In consideration of the acceptance of this entry, I assume full and complete responsibility for any injury or accident, which may occur while I am traveling to or from THE EVENT, during THE EVENT, or while I am on the premises of THE EVENT.
5. I agree that if I am injured or require medical assistance beyond the capabilities of the race course medic teams on site, THE ORGANIZER may, at my cost, arrange medical treatment and emergency evacuation as deemed necessary by the race medical teams and THE ORGANIZER.
6. I, for myself and my heirs and executors, agree to release, indemnify and hold harmless THE ORGANIZER, its officers, employees, agents, volunteers, contractors, public bodies, landholders and sponsors, from and against any and all claims, demands, right or cause of action, suits, expenses, costs and proceedings of any nature whatsoever which may be made by me or on my behalf or by other parties for or in respect of or arising out of any injury, loss, damage or death caused to me or my property as a result of my entry or participation in THE EVENT whether by negligence, breach of contract or in any way whatsoever.
7. I also agree that in the event I am injured or my property is damaged, I will bring no claim, legal or otherwise, against THE ORGANIZER in respect to that injury or damage.
8. I understand that my medical history and personal information, collected as part of the entry process for THE EVENT, may be made available to the Events medical team and operations team to assist in the case of any medical emergency.
9. I agree to allow my name, results, photographs, videos, multimedia, or film likeness to be used for any legitimate purpose by THE ORGANIZER, the sponsors, event partners, or assigns without payment or compensation.
10. I agree to abide by THE EVENT rules and the directions of all Event officials.
11. I acknowledge that THE ORGANIZER may change the advertised course without notice if THE ORGANIZER deems this necessary. I also acknowledge that THE ORGANIZER may cancel THE EVENT due to weather conditions, safety considerations, terrorism or 'acts of god' and that in such circumstances my entry fee will be non-refundable.
12. I acknowledge that THE ORGANIZER cannot be held responsible for travel restrictions or any other restrictions related to Covid-19 imposed by Authorities that may affect by participation in THE EVENT.
